ARTICLES OF INCORPORATION  
OF  
ENCHANTED VALLEY ROAD USERS, INC.  
A Nonprofit Corporation

**THE UNDERSIGNED**, acting as incorporator of a nonprofit corporation under the Idaho Nonprofit Corporation Act, adopts the following Articles of Incorporation for such corporation:

**FIRST**

The name of the corporation is **ENCHANTED VALLEY ROAD USERS, INC.**

**SECOND**

The corporation is a nonprofit corporation.

**THIRD**

The period of its duration is perpetual.

**FOURTH**

The purposes and objects for which the Corporation is formed shall be to obtain easements, rights of way, hold, manage and regulate the road system thereon described in the Bylaws of the corporation subject, however, to the rights of others to maintain, repair, replace, construct water lines and water systems and all equipment and control used in connection or as a part thereof, exclusively for the benefit of its members, and as incidental to that object and purpose, to undertake and transact such lawful activities as are set forth in the Bylaws of the corporation and to have and to exercise any and all powers and privileges now or hereafter conferred by the laws of the State of Idaho upon corporations formed under the Idaho Nonprofit Corporation Act of this state, or under any act amendatory thereof or supplemental thereto or substituted therefor.

**FIFTH**

The corporation shall not be authorized or empowered to issue capital stock or shares. The corporation shall have members with eligibility requirements and rights of membership set forth in the Bylaws.
