## ARTICLES OF INCORPORATION OF THE

## UNION CONGREGATIONAL CHURCH OF BURKE.

KNOW ALL MEN BY THESE PRESENTS: That J.C. Bushnell Mrs. Minnie
Bushnell, Mrs. Jennie Sweet, Mrs. Mary C. Anno, T.D. Anno Mrs. Arabelle
Scott, all residents of the Town of Burke, in the Count; of Shoshone,
State of Idaho, do hereby associate ourselves together for the
purpose of incorporating a charitable association, under the following articles of incorporation.

- 1. The name of the said corporation shall be the Union Congregational Church of Burke.
  - 2. The purposes for which said corporation is formed are:

To acquire, purchase, receive, have and hold any real-estate which it may deem necessary or expedient, in trust for the use of said association, in erecting and maintaining any and all buildings to be now used or hereafter erected upon real-estate to be acquired, for the worship of Almightly God and the furtherance of religion according to the doctrines, discipline and worship of the Congregational belief, or for the administration of charity for the bodies and souls of men, or for any other purpose that may be according to the constitution and covenants of said Church as ordained in the United States of America; and to sell grant, bargain, devise ordispose of such real-estate as it may deem necessary and expedient; to acquire, purchase, receive and hold any legacies, donations, moneys, goods and chattels in trust for the use of said association, and to erect, build, construct and maintian churches, rectories, carriage houses, school houses, hospitals, and any and all other buildings necessary and to the full use and enjoyment of the real-estate hereafter acquired as aforesaid.

3. The term for which said corporation is to exist is for the period of fifty years.

4. The number of directors of the said corporation shall be five and the names and residents of those who are elected for the first year, to wit: until 1st December 1904, are as follows:-
