



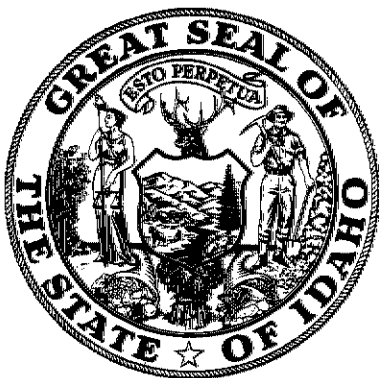
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

OF

BISHARAT INC.

ARTICLE 1

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being over the age of twenty-one (21) years of age, have this day voluntarily associated ourselves for the purpose of forming a Corporation under the Idaho Business Corporation Act, and pursuant to the Laws of the State of Idaho, we hereby adopt in duplicate the following Articles of Incorporation.

ARTICLE 11

The name of this Corporation is and shall be: BISHARAT INC.

ARTICLE 111

Its principals office in the State of Idaho is located at 1510 Bench Rd Apt A-5 Pocatello, Id 83201. The name and address of its Resident Agent is ISSA E. BISHARAT, 1510 Bench Road Apt. A-5, Pocatello, Idaho 83201.

1. In furtherance of and not in limitation of the general powers conferred by the Laws of the State of Idaho, it is expressly provided that this Corporation shall also have the following powers:
 - a) To acquire by purpose or otherwise and to own, hold, cancel, reissue, sell, pledge and otherwise deal in the stock of this Corporation, provided that the money or property of this Corporation shall not be used for the purchase of shares of its own stock when such use would cause any impairment of the capital of the Corporation. The Corporation shall not be entitled to vote, either directly or indirectly, on any shares of its own stock which it may hold.
 - b) To acquire by purchase or otherwise and to own, hold, cancel, reissue, sell, pledge, and otherwise deal in the bonds, debentures, notes and other securities and obligations of this Corporation.
 - c) To acquire money and give security therefore.
 - d) To enter into, make, perform and carry out contracts of every kind for any lawful purpose pertaining to its business, with any individual, entity, firm, association or corporation, or with any governmental, municipal, or public authority, domestic or foreign in accordance with the Corporation Laws of the State of Idaho.

- e) To do everything necessary, proper, convenient, or incidental to the accomplishment of the purpose and objects of this Corporation, or which is calculated directly or indirectly to promote the welfare or interests of the Corporation or enhance the value or render profitable any of its property or rights.
- f) To do any and all of the things in this Articles set forth, to the same extent as a natural person might or could do, and in any part of the world, as principal, agents, contractors, trustees, or otherwise, either alone or in company with others.
- g) In addition to the foregoing objects and purposes for which the Corporation is formed, this corporation shall have the power and right to do any and all things permitted to be done by the corporation formed under the laws of the State of Idaho and shall have the power and right to do any and all things not expressly prohibited by the Corporation Laws of the State of Idaho.

The foregoing statement or purpose shall be construed as a statement of both purposes and powers, and the purposes and powers in each clause, shall, except where otherwise expressed, be in no wise limited or restricted by the reference to or inference from the terms or provisions of any other clause, but shall be regarded as independent purpose.

ARTICLE IV

The Corporation shall have authority to issue 10,000 shares of common stock at no value.

ARTICLE V

The number of Directors constituting the initial Board of Directors will be FOUR and the initial name and address of the persons who are to serve until the First Annual Meeting of Stockholders, or until their successor's be elected and qualify are as follows:

Said number may at anytime be increased or decreased by a duly adopted amendment to these Articles of Incorporation, or a By-Law or an Amendment to a By-Law duly adopted, prior the issuance of any shares of the capital stock, by the Stockholders. There will be four initial stockholders.

ARTICLE VI

The duration of this Corporation shall be perpetual.

ARTICLE VIII

ARTICLE IX

The capital stock, after the amount of the subscriptions price, or par value, has been paid in shall be subject to no further assessment to pay debts of the Corporation, and no stock issued as fully paid up shall ever be assessable or assessed, and these Articles of Incorporation shall not end and cannot be amended or end, regardless of the vote thereof, and as to amend, modify or recind this ARTICLE IX or any of the provisions thereof.

ARTICLE X

The undersigned being the Original Incorporators hereinabove named for the purpose of forming a Corporation to do business within and without the State of Idaho and being natural persons and over the age of consent, do make this Certificate, hereby declaring and certifying that the facts stated are true and for the use and purposes as hereinabove stated.
