Articles of Incorporation/Idaho Performing Artists Foundation/Education, INCORPORATED

The undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of the State of Idaho, do hereby certify:

First: The name of the Corporation shall be the Idaho Performing Artists Foundation/Education, |NCORPORATED

Second: The place in this state where the principal office of the Corporation is to be located is the City of Boise. Ada County.

Third: The period of duration of the corporation shall be perpetual.

Fourth: Said corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law). More specifically, the corporation is a fund raising organization, the exclusive purpose of which is to raise and distribute funds for the support of the performing artist programs of institutions of higher learning located within the state of Idaho and to non-profit institutions of elementary, secondary, or higher education located within the state of Idaho. To this end, the corporation shall make, as it is able, grants of money, in the areas of serious music, dance, and theater, to said educational institutions for the support of (1) scholarship, sabbatical, and grant programs for both students and staff, (2) performance and concert programs which provide performing opportunities for students and staff.

<u>Fifth</u>: No part of the income of the corporation shall inure to the benefit of, or be distribtable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Fourth hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing and distribution of statements) any political campaign on behalf of any candidate for public office.

Notwithstanding any other provisions of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (for the

corresponding provision of any future United States Internal Revenue Law).

<u>Sixth</u>: The corporation has members and the business and affairs of the corporation shall be vested, managed, and controlled by the membership of the corporation as set forth in its by-laws and pursuant to section 30-314 of the Idaho Code.

Seventh: The street address of the initial registered office of the corporation is: 2407 Sunrise Rim Rd., Boise, Idaho 83705. The name of the initial registered agent of the corporation is: Stuart Evett.

<u>Eighth</u>: The names and addresses of the persons who are the initial trustees of the corporation are as follows:

Ninth: The names and addresses of the initial incorporators are as follows:

Tenth: Upon the dissolution of the corporation, the membership shall, after paying or making provision for the payment of all of the liabilities of the corporation, dispose of all of the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at that time qualify as an exempt organization or organizations under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law), as the membership shall determine. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
