ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That whereas, the undersigned are desirous of associating ourselves together for the purpose of establishing and conducting a benevolent, charitable and non-profit association to own and operate a hospital in which to receive and treat the sick, wounded and infirm, we hereby certify:

FIRST:

That the name of this corporation shall be the STEELE MEMORIAL HOSPITAL, INC.

SECOND:

That the purpose of said corporation is, and shall continue to be, to carry on and conduct the business of maintaining a hospital in the City of Salmon, County of Lemhi, State of Idaho, by purchasing, leasing and holding real estate for hospital and hospital grounds, selling and exchanging the same, erecting and managing hospitals with their equipment thereon, doing all things incidental thereto, for the reception and treatment medically and surgically or otherwise of such classes of the sick, wounded, diseased and infirm as may be admitted under the rules and regulations to be established by the directors thereof.

THIRD:

That the period of the existence and the duration of the life of this corporation shall be perpetual.

FOURTH:

That the location and post office address of the registered office of this corporation shall be Salmon, Idaho.

FIFTH:

That there is no capital stock of this corporation.

SIXTH:

That the number of directors of this corporation shall be five in number, who are residents of Lemhi County, Idaho.

EIGHTH:

That this corporation is not organized for pecuniary profit nor shall it have any power to issue certificates of stock or to make or declare dividends, and no part of its net earnings shall inure to the benefit of any individual, and no substantial part of its activities shall be carrying on propaganda or otherwise attempting to induce legislation, and the same is not organized or shall it be conducted for the purpose, directly or indirectly, of fixing the price, or regulating the production of any article of commerce or of products of the soil, or of consumption by the people. If there be any cash profits resulting from the carrying on of the business of such corporation, the same shall be devoted exclusively by the officers of such corporation toward the charitable objectives and purposes of the corporation for hospital purposes solely. Upon the dissolution or other termination of such corporation, the balance, if any, of any and all money or / property owned by the corporation or received from bequests, gifts or otherwise, or from its operations shall, after the payment in full of its debts and obligations or after the making of adequate

provision therefor, be used and distributed exclusively for one or more charitable, scientific or educational purposes.
