ARTICLES OF INCORPORATION 90 DEC 13 AM 8 49

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

Article I

The name of the corporation shall be BIG SKY OIL COMPANY, INC.

Article II

The period of its duration is perpetual.

Article III

The purpose or purposes for which the corporation is organized are: to carry on the business of retail sales of petroleum/fuel products, any lawful activity related to such business, and the transaction of any or all other lawful business for which a corporation may be incorporated under the Idaho Business Corporation Act.

Article IV

The aggregate number of shares which the corporation shall have authority to issue is 10,000 with no par value.

Article V

There are no provisions denying preemptive rights.

Article VI

The mailing address of the initial registered office of the corporation is P. O. Box 937, Mountain Home, Idaho 83647, and the name of its initial registered agent at such address is Alan T. Bermensolo. The physical address of the registered agent is 980 North 13th East Street, Mountain Home, Idaho 83647.

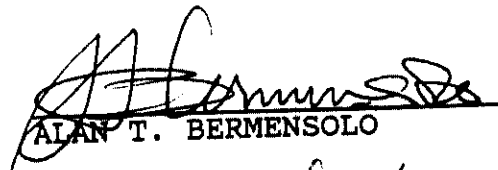

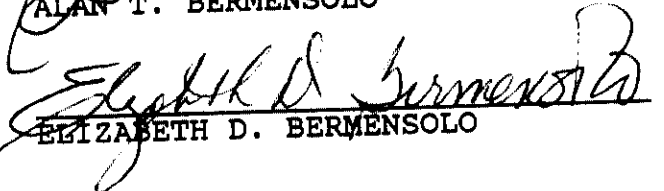
