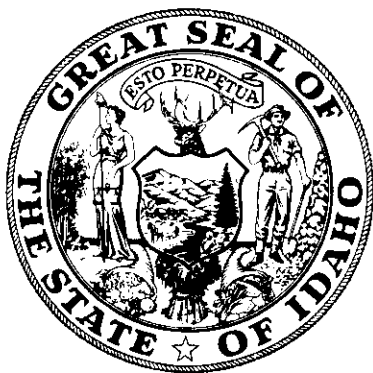

ARTICLES OF INCORPORATION  
OF  
QUICK RESPONSE UNIT OF ALBION, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the under-  
signed have voluntarily associated ourselves together for the  
purpose of forming a nonprofit corporation without capital stock  
pursuant to the Idaho Nonprofit Corporation Act (Idaho Code §30-  
301 et seq), and we do hereby certify:

Article I.

The name of this corporation shall be Quick Response  
Unit of Albion, Inc.

Article II.

The Quick Response Unit of Albion, Inc. shall be a  
nonprofit corporation and shall have no capital stock and shall  
pay no dividends or salaries to its incorporators, officers, or  
board members.

Article III.

This corporation shall have perpetual existence.

Article IV.

The purpose and objects for which such corporation is  
formed are as follows:

1. To provide emergency care for ill and injured persons,  
and perform rescue-extrication when necessary, within the limita-  
tions of the knowledge and skills afforded members by the Quick  
Response Unit Training Course and within the geographic limits for  
response as defined by the Director of the Office of the Emergency  
Medical Services, until the arrival of an ambulance summoned by  
members that will transport the patient to a hospital.

2. To continue to upgrade the knowledge and skills of  
the members for emergency care of ill and injured persons through  
periodic training sessions of which there shall be no less than one

1 every three months.

2 3. To promote community understanding of accident pre-  
3 vention and first aid techniques!

4 Article V.

5 This corporation shall have one class of members, said  
6 memberships to be purchased according to procedure to be adopted  
7 in the By-Laws; such membership being available to all members of  
8 the general public; and such membership entitling each member to  
9 one vote in all elections held by the corporation.

10 Article VI.

11 The initial registered agent of this corporation shall  
12 be Keith Amende and the street address of its initial registered  
13 office shall be Albion, Idaho 83311.

14 Article VII.

15 The board of directors of this corporation shall consist  
16 of its officers and its elected directors, but in no instance  
17 shall the number of directors be less than five. The government,  
18 membership, and officers, meetings and elections shall be pre-  
19 scribed by the By-Laws of the said corporation. The initial board  
20 shall have five directors, consisting of:
