

# ARTICLES OF INCORPORATION OF THE MOUNTAIN HOME HUMANE SOCIETY, INC.

Articles of incorporation of the Mountain Home Humane Society, Inc., a non-profit association, organized pursuant to Title 30, Chapter 3 of the Idaho Code.

## ARTICLE I.

The name of this organization shall be the "MOUNTAIN HOME HUMANE SOCIETY, INC." hereafter referred to at the MHHS.

## ARTICLE II.

This is a non-profit corporation.

## ARTICLE III.

The duration for which this corporation is organized is perpetual.

#### ARTICLE IV.

This corporation is formed as a humane society.

#### ARTICLE V.

The principal place of business of this corporation shall be the City of Mountain Home, County of Elmore, State of Idaho.

#### ARTICLE VI.

This corporation shall have no capital stock, but shall be a membership organization and shall issue certificates of membership.

# ARTICLE VII.

No member, director or officer of this corporation shall be individually or personally liable for debts, liabilities, or obligations of the corporation.

## ARTICLE VIII.

This corporation shall be authorized to exercise all powers conferred upon humane societies by statute, may hold real personal property, may receive and hold in trust or otherwise funds received by gift or bequest to be devoted by it to such purposes, to make and enforce contract. It shall have the power to dispose of any or all of its property. However, when any real or personal property of greater value than \$100.00 is sold the proceeds shall be reinvested for the benefit of the society. It shall generally have power to do any and all things necessary to carry charitable, benevolent, humane, scientific, medical, or educational work.

The objectives of the MHHS shall be to enforce laws regulating and governing loose, unwanted, abandoned, and stray animals; to find homes for these animals or return them to their homes; to maintain these animals in a clean and healthy condition until homes can be established for them; and to dispose of animals humanely that cannot be adopted.

## ARTICLE X.

The initial registered agent is Ginger Salvo. The initial registered office of this corporation is at 1190 S. Main Street, Mountain Home, Idaho 83647.
