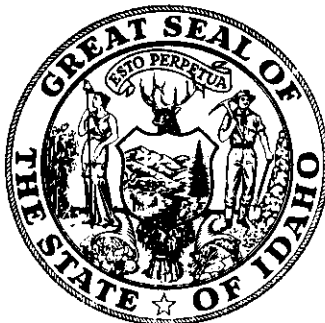

**AMENDED ARTICLES OF INCORPORATION OF  
INTERMOUNTAIN HAND CLINIC, P.A.**

DEC 30 9 48 AM '94  
Pursuant to the provisions of Section 30-1-59 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Amended Articles of Incorporation:

**I. NAME OF THE CORPORATION.**

The name the corporation prior to the adoption of these Amended Articles of Incorporation was Intermountain Hand Clinic, P.A.

**II. AMENDMENTS ADOPTED.**

The following amendment to the Articles of Incorporation was adopted by the Corporation in the manner prescribed by the Business Corporation Act:

**RESOLVED** that ARTICLE I, of the Articles of Incorporation be amended, to read as follows:

**ARTICLE I

The number of shares outstanding is 5,000 and the number of shares entitled to vote on the amendment is 5,000.

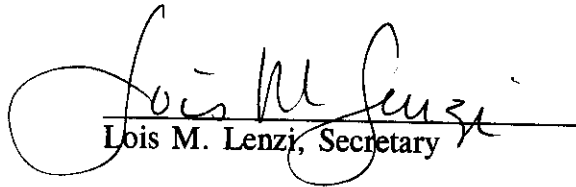
**V. VOTE ON AMENDMENT.**

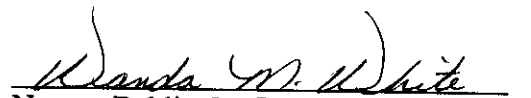

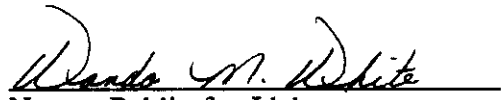
