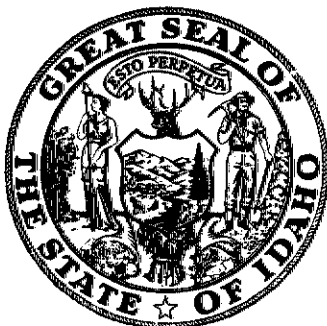

#### **NO PENDING SUITS**


There are no suits pending against the corporation in any court.
