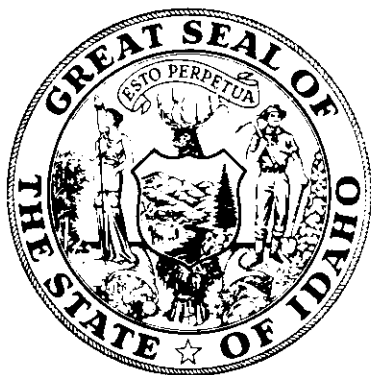
**CERTIFICATE OF WITHDRAWAL
