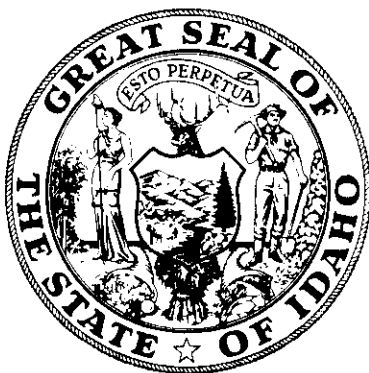

- I. The name of the corporation is: LARAN AGENCY, INC.
- II. The period of duration shall be perpetual.
- III. The purpose of the corporation shall be as follows:

To conduct any or all of the business of a motorized escort service and to do all other things necessary and pertaining thereto;

To conduct any or all of the business of a personal protection and specialized transportation service as it relates to the protection of the persons to be transported and to do all other things necessary and pertaining thereto;

To conduct any or all of the business of a private police agency and / or contracted law enforcement as may be contracted by persons or municipalities and to do all other things necessary and pertaining thereto.
