ARTICLES OF INCORPORATION

The undersigned incorporator, desiring to form a corporation pursuant to the provisions of the Idaho Business Corporation Act, adopts the following articles of incorporation:

ARTICLE ONE

 $\underline{\text{Name}}$. The name of the corporation is LEWISTON STEAK HOUSES, INC.

ARTICLE TWO

Purposes. The purposes of the corporation are to operate Bonanza steakhouses in Lewiston, Idaho and to engage in any or all lawful business for which corporations may be organized under the Idaho Business Corporation Act.
