KNOW ALL MEN BY THESE PRESENTS: That the undersigned, an adult citizen of the United States and resident of the State of Idaho, does hereby establish Wilco, Inc., as a corporation under the provisions of Chapter 1, Title 30, Idaho Code, and in furtherance of said purpose does hereby certify:

- 1. Name. The name of the Corporation is Wilco, Inc.
- 2. <u>Purposes</u>. The Corporation is established for the purpose of conducting any and all business that may be conducted by or on behalf of corporations in the State of Idaho.
- 3. <u>Duration</u>. The Corporation shall have perpetual existence.
- 4. Authorized shares. The aggregate number of shares which the Corporation shall have authority to issue is 5,000 shares of the par value of \$1.00 each, all of one of class, which shall be designated common stock.
- 5. Registered office and agent. The address of the initial registered office of the Corporation is 161 Main Street, Gooding, Idaho 83330. The name of the initial registered agent at such address is Keith A. Wilkins.
- 6. <u>Directors</u>. The management of the affairs of this Corporation shall be vested in the Board of Directors. The Board shall initially consist of one director, namely, Keith A.

The Board, pursuant to procedures established in the By-Laws of the Corporation, may increase the number of directors to a maximum of three, provided that no person shall serve as a director who is not a shareholder of the Corporation. Other qualifications of the directors, their terms of office, and manner of election or appointment shall be provided for in the By-Laws. Keith A. Wilkins, 161 Main Street, Gooding, Idaho 83330, shall serve as sole director until the first annual meeting of shareholders or until his successor or successors be selected and qualified.

- 7. Incorporator. The name and address of the incorporator of this Corporation is Keith Wilkins, 161 Main Street, Gooding, Idaho 83330. Said incorporator is a shareholder of the Corporation, having subscribed to all authorized shares of the capital stock.
- 8. <u>Amendments</u>. These Articles of Incorporation may be altered or amended in any manner as provided by law.
