know all men by these presents, that we, the undersigned, being all bona fide residents of the United States of America, and each being over the age of eighteen (18) years, do under and in pursuant of the general corporation laws of the State of Idaho, hereby organize, constitute and associate ourselves and such other persons as may hereafter become associated with us into a body politic and corporate, and to that end execute the following ARTICLES OF INCORPORATION, and we hereby set forth and declare as follows:

I.

The name of this corporation is and shall be MOBILE AUTO INC. SOUND,/ The registered office shall be 9311 West Moose Road, City of Pocatello, State of Idaho, County of Bannock. The registered agent shall be EDMOND L. REMER, with the same address as the registered office.

II.

The term of the existence of this corporation shall be perpetual.
