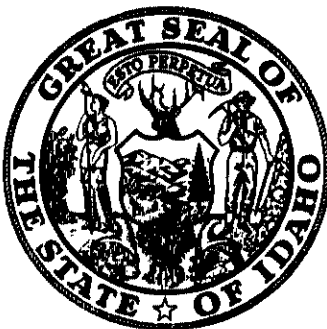
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION
OF

The undersigned, in order to form a corporation pursuant to Idaho Business Corporation Act, certify as follows:

ARTICLE I

The name of the corporation is JB Consulting & Importing, Inc. (hereafter "Corporation").

ARTICLE II

The purposes for which this Corporation is organized are as follows:

1. To engage in consulting and importing; and
2. To engage in any other lawful activity or business for which corporations may be incorporated under the Idaho Business Corporation Act.

The Corporation shall have perpetual existence.
