AMENDED AND RESTATED ARTICLES OF INCOMENTION STATE

Pursuant to the provisions of Section 30-1-59 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is TREASURE VALLEY CERTIFIED DEVELOPMENT CORPORATION ("Corporation").

ARTICLE II

AMENDMENT ADOPTED

The following amendment to the Articles of Incorporation was adopted by the Corporation in the manner prescribed by the Idaho Business Corporation Act:

RESOLVED that FIFTH ARTICLE of the Amended and Restated Articles of Incorporation of the Corporation be amended to read in full as follows:

<u>FIFTH</u>: The management of this Corporation shall be vested in a Board of Directors of not less than five (5) or more than twenty-one (21) Directors, as may be fixed by the By-Laws, who must meet at least once every other month. Any meeting of the shareholders or the Board of Directors shall be held within or without the State of Idaho.
