

The final order of disincorporation for the City of Parkline was effective September 7, 2001. Please find a copy of the order attached.



ORDER OF DISINCORPORATION  
OF THE CITY OF PARKLINE,  
BENEWAH COUNTY, IDAHO

The Board of County Commissioners of Benewah County, Idaho, having been advised by the Mayor and City Council of the City of Parkline, Idaho, that canvass of votes on the issue of disincorporation of the City of Parkline, Idaho, showed that at the election on the issue of disincorporation, that a majority of the voters, in excess of two-thirds (2/3) of the number of votes cast, were in favor of disincorporation, and the Board being fully advised, now makes the following findings and order:

1. That at the election held on August 7, 2001, on issue of disincorporation of the City of Parkline, Idaho, that all necessary notices were given and proceedings had, and that said election was called and conducted in the manner prescribed pursuant to Title 50, Chapter 22 of the Idaho Code.
2. That at said election nineteen (19) ballots had been cast, and that the result thereof, as revealed by count of said votes and subsequent canvass of the same were as follows:

In favor of disincorporation	17 Votes
Against disincorporation	2 Votes

3. The Board finds that all proceedings were taken in accordance with law, and particularly Idaho Code 50-3205 and correlated provisions, and that the Petition for Disincorporation should be granted,

NOW THEREFORE, pursuant to the cited statutes, and to the procedures taken thereunder,

IT IS HEREBY ORDERED that the Petition for Disincorporation of the City of Parkline, Benewah County, Idaho, be and the same is hereby granted.

IT IS FURTHER ORDERED that the municipal corporation, that being the City of Parkline, Benewah County, Idaho, shall be and the same is hereby disincorporated.

IT IS FURTHER ORDERED that this Order of Disincorporation shall take effect and be in final effect on September 7, 2001.

IT IS FURTHER ORDERED that the Clerk of the Board of County Commissioners, Benewah County, Idaho, in cooperation with former officers of the City of Parkline, Idaho, is authorized and directed to proceed under the provisions of Idaho Code 50-2206 and correlated statutes, with the procedures prescribed for finally winding up all municipal affairs of said City, including transmission of remaining funds to Benewah County, Idaho, and disposition of City records and other matters involved with the closing of City affairs as provided by law.
