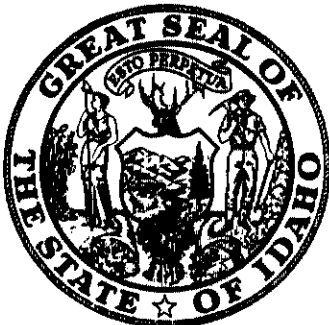

ARTICLES OF INCORPORATION
OF

The undersigned, acting as incorporator(s) of a corporation under the Idaho Business Corporation Act, adopt(s) the following Articles of Incorporation for such corporation:

ARTICLE I

NAME: The name of this corporation shall be TETON CAMPERS, INC.

ARTICLE II

DURATION: The duration of the corporation shall be perpetual

ARTICLE III

PURPOSE AND POWERS: The purpose(s) for which this corporation is organized are:

(a) To engage in the manufacturing, purchase, repairing, selling, and/or reselling of recreational vehicles and/or custom modified or manufactured vehicles together with anything reasonably incidental or necessary thereto.

(b) To have all rights and powers normally ascribed to and incidental to said primary purposes and to business operations in general including, but not limited to; raising capital and operating monies; entering into joint ventures or limited partnerships; acquiring, by purchase or otherwise, maintaining, developing, improving, financing, mortgaging, selling, renting, or exchanging such real property, equipment and other facilities as are needed by the Corporation, and to undertake all business transactions, functions and service ordinary and necessary to the business, as set forth above, or any other lawful business authorized under the laws of this State.

(c) To have as its purpose the pursuit and development of any other business opportunities that relate to its primary purpose, as set forth above.

(d) To engage in any other lawful activities permitted by the Idaho Business Corporation Act.

ARTICLE IV

AUTHORIZED SHARES: The aggregate number of shares of common voting stock which the Corporation shall have authority to issue is 10,000, all of which shall have no par value.

NO LIABILITY: The private property of the stockholders of this corporation shall not be subject to the payment of corporation debts to any extent whatsoever.


