The undersigned, being over 18 years of age, a citizen of the United States of America and a person duly licensed by the state of Idaho to engage in the profession of ophthalmology, hereby forms the following professional service corporation pursuant to the Idaho Professional Service Corporation Act.

Ι

The name of the corporation is EYE CLINIC OF SANDPOINT, P.A.

II

The period of its duration is perpetual.

III

The purpose for which the corporation is organized is to engage in the practice of ophthalmology and allied professional services.

This corporation may not render such professional services except through its officers, employees and agents who are duly licensed or otherwise legally authorized to render such professional services in Idaho.

IV

The aggregate number of shares which the corporation shall have authority to issue is 5,000 shares, all one class, and of \$1.00 par value.

Shareholders may include only natural persons who themselves are duly licensed or otherwise legally authorized

The number of directors constituting the initial board of directors of the corporation is one (1) and the name and address of the person who is to serve as director until the first annual meeting of shareholders or until his successor is elected and shall qualify is: Charles C. George, M.D., 5575 Baldy Mountain Road, Sandpoint, ID 83864.

Except as provided in Section 30-1309A, Idaho Code, no person who is not licensed or otherwise legally authorized to practice ophthalmology in Idaho may be a shareholder or serve as a director or general officer of this corporation, provided however, that as long as there shall be only one shareholder of this corporation, the office of secretary may be held by a person who is not licensed or otherwise legally authorized to practice ophthalmology in Idaho.
