ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

SNAKE RIVER TIRE CENTER, CORP.

Pursuant to the provisions of the Idaho Business Corporation law, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I.

The name of the corporation is: Snake River Tire Center, Corp.

ARTICLE II.

The following amendment of the ARticles of Incorporation was adopted by the Stockholders of the corporation on the 18th day of October, 1975, in the manner prescribed by I.C. Section 30-126:

Article I of the Articles of Incorporation is hereby deleted and replaced with the following provision; "The name of this corporation is Snake River Tire, Corp."

ARTICLE III.

The number of shares of the corporation outstanding at the time of such adoption was none; and the number of shares entitled to vote thereon was none.

ARTICLE IV.

The Articles of Amendment to the ARticles of Incorporation were unanimously agreed to by the original
