THE UNDERSIGNED, a natural person over the age of eighteen (18) years, does hereby form a corporation under the laws of the State of Idaho, as contained in Chapter 1 of Title 30, <u>Idaho Code</u>, entitled "Idaho Business Corporation Act," and to that end does hereby certify:

ARTICLE I

Name

The name of said corporation shall be Finish Line Foods, Inc.

Purposes and Powers

Registered Office

The registered office of said corporation in the State of Idaho shall be located at 2144 Hillcrest Lane, Twin Falls, Idaho 83301, in the County of Twin Falls, Idaho. Karen York shall be the registered agent at the address set forth above.
