KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of legal age, and at least two-thirds of us being citizens of the United States of America, in order to form a corporation for the purposes hereinafter states pursuant to the Business Corporation Act of Idaho, do hereby certify as follows:

FIRST:

The name of the corporation is Wave Lengths, Inc.

SECOND:

The purposes for which said corporation is formed are:

To operate a beauty salon and to offer items of beauty related merchandise for sale to the public, together with all other functions of a beauty salon company and all related business activities and the transaction of any or all lawful business for which corporation may be incorporated under the Idaho Business Corporation Act.

THIRD:

The location and post office address of the registered office of the corporation is 625 21st Street, Suite B, Lewiston, Idaho 83501, and the registered agent is Katherine E. Clark.

FOURTH:

The total authorized number of common shares is 100,000 shares of the par value of \$1.00 per share for an aggregate par value of \$100,000.00.

FIFTH:

The names and post office addresses of the incorporators and the number of shares subscribed by each are as follows:

SIXTH:

The private property of the stockholders shall not be subject to the payment of corporate debts to any extent whatever.

SEVENTH:

The board of directors shall consist of two (2) directors, namely:

Katherine E. Clark

John A. Church

or such other number as shall be established by the Bylaws of the corporation. Any vacancies occurring in the office of any director, however occasioned, may be filled by the remaining members of said board. Upon failure of the board to elect, a special meeting of the stockholders shall be called to fill the vacancy.

EIGHTH:

The existence of this corporation is to be perpetual.

NINTH:

The directors shall have the power to make and to alter or amend the Bylaws, to fix the amount to be reserved as working capital and to authorize and cause to be executed mortgages and liens without limit as to the amount upon the property of this corporation.


TENTH:


