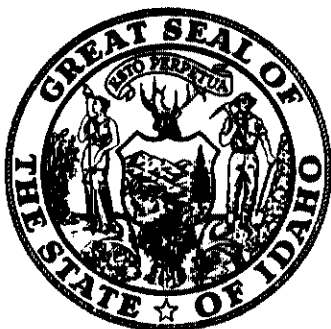

THIS IS TO CERTIFY that I, the undersigned, hereby incorporate pursuant to the Laws of the State of Idaho providing for the formation of corporations for profit, for the purposes and with the powers hereinafter stated.

I

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is Five Hundred (500) shares of No Par common stock.
