The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

**FIRST:** The name of the corporation is: Hi Tech Fire Protection, Inc.

**SECOND:** The period of its duration is perpetual.

**THIRD:** The purpose of purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.


