

ARTICLES OF INCORPORATION
OF
YOUNG'S DIESEL SERVICE, INCORPORATED

WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following articles of incorporation for such corporation"

- FIRST: The name of the corporation is YOUNG'S DIESEL SERVICE, INCORPORATED.
- SECOND: The period of its duration is Perpetual.
- THIRD: The purpose(s) for which the corporation is organized are, to rebuild, repair, maintain trucks, buses auto and litterain vehicles and any other types of motors and motorized conveyances, and to transact any ~~lawful~~ business for which corporations may be incorporated under this act.
- FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 25,000 of comon stock, one class only with a par value of \$1.00 each.
- FIFTH: The corporation will not commence business until at least ONE THOUSAND DOLLARS (\$1,000.00) have been received by it as consideration for the issuance of shares.
- SIXTH: Cumulative voting of shares of stock is authorized.
- SEVENTH: Provisions limiting or denying to shareholders the preemptive right to acquire additional or treasury shares of the corporation are: NONE.
- EIGHTH: Provisions for the regulation of the internal affairs of the corporation are: to be set forth in the Bylaws as permitted under this act.
