ARTICLES OF INCORPORATION

OF

YOUNG'S DIESEL SERVICE, INCORPORATED

WE, THE UNDERSIGNED, natural persons of legal age, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following articles of incorporation for such corporation"

FIRST: The name of the corporation is YOUNG'S DIESEL SERVICE, INCORPORATED.

SECOND: The period of its duration is Perpetual.

The purpose(s) for which the corporation is organized are, to rebuild, THIRD: repair, maintain trucks, buses auto and llterain vehicles and any other

types of motors and motorized conveyances, and to transact any Lawful business for which corporations may be incorporated under this act.

The aggregate number of shares which the corporation shall have authority FOURTH:
