ARTICLES OF INCORPORATION
of
BITTNER INVESTMENT SERVICES, INC.

The following Articles of Incorporation are hereby adopted pursuant to the Idaho Professional Service Corporation Act.:

1. Name.

The name of the corporation is:
Bittner Investment Services, Inc.

2. Duration.

The corporation shall have perpetual duration.

3. Purposes.

The corporation is formed for the sole and specific purpose of providing investment and brokerage services. The corporation may invest its funds and own property as authorized by law.

4. Authorized Shares.

The corporation shall be authorized to issue 2,000 shares, all of one class, for a par value of \$1.00 per share.


