ARTICLES OF AMENDMENT  
of  
TETON VALLEY CHAMBER OF COMMERCE, INC.  
formerly  
TETON VALLEY BUSINESSMEN'S ASSOCIATION, INC.

Pursuant to Section 30-327 of the Idaho Nonprofit Corporations Code, the corporation adopts the following articles of amendment to its articles of incorporation:

ONE: ARTICLE I is hereby amended by striking the words, "The name of the corporation is TETON VALLEY BUSINESSMEN'S ASSOCIATION, INC." and by adding the words, "The name of the corporation is TETON VALLEY CHAMBER OF COMMERCE, INC.".

TWO: The foregoing amendment of the articles of incorporation was adopted at the corporation's regularly scheduled meeting of members on November 12, 1992, at which time a quorum was present. The amendment received the approval of at least two-thirds majority vote of said members entitled to vote in person or by proxy, as well as the approval of the Board of Directors.
