ARTICLES OF INCORPORATION OF

ROCK SAW, INC.

The undersigned, acting as incorporators of a corporation of the corporat under the Idaho Corporation Act, adopt the following Article of Incorporation for this corporation.

I.

The name of this Corporation shall be Rock Saw, Inc.

II.

The period of existence and duration of the life of this corporation shall be perpetual.

III.

The address of the initial registered office of this corporation is 5405 Overland Road, Boise, Idaho 83705, and the name of the initial registered agent as such address is James W. Kiser.

IV.

The nature of the business and the object and purpose of this corporation shall be as follows:

- Owning, managing and operating a trencher and heavy (a) equipment business; the sale, leasing, servicing of trenchers and heavy equipment.
- The transaction of any or all other lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLES OF INCORPORATION - 1

That the total authorized number of par value shares of this corporation shall be one thousand (1,000), all of one class, each of a par value of \$1.00, which said shares shall be common stock and shall not be subject to assessment.

VII.

The first Board of Directors shall consist of two directors, but during their term of office, or thereafter, the number of directors may be decreased or increased from time to time as may be provided by the By-Laws; provided, however, that the number of directors constituting a Board shall not be less than (2) nor more than five (5).

ARTICLES OF INCORPORATION - 2

All or any meeting of the shareholders, or of the Board of Directors may be held within or without the State of Idaho.

IX.

Each shareholder of this corporation shall have a pre-emptive or other right to purchase, subscribe for, or take any part of any stock or any part of the debentures, bonds or other securities convertible into stock of this corporation issued, optioned or sold by it after its incorporation in proportion to existing stock ownership. Any part of the capital stock, debentures, bonds or other securities convertible into stock of this corporation authorized by these Articles of Incorporation or by any amended articles duly filed, may at any time be issued, optioned for sale and sold or disposed of by this corporation pursuant to a resolution of its Board of Directors to such persons and upon such terms as may to such Board seem proper only after being first offered to existing shareholders in proportion to their stock ownership.

Χ.

These Articles of Incorporation can only be amended by a vote of sixty-five percent (65%) or more of the outstanding issued stock. Authorized stock in this corporation may only be issued by a vote of sixty-five percent (65%) or more of the outstanding issued stock.
