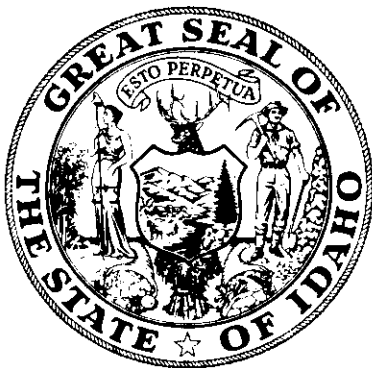

ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION

IDAHO STEELHEAD & SALMON UNLIMITED, INC.

Pursuant to the provisions of Section 30-326 and 30-327 of the Idaho Nonprofit Corporation Act, the undersigned non-profit corporation adopts the following Articles of Amendment to its Articles of Incorporation:

The amendments made herein are in addition to the original Articles of Incorporation and the full text of each amended provision is as follows:

1. ARTICLE TEN: This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of section 501(c)(3) of the Internal Revenue Code.

2. ARTICLE ELEVEN: Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code.

3. All remaining provisions of the Articles of Incorporation originally adopted are hereby reaffirmed and ratified.

4. That this Amendment to the Articles of Incorporation was adopted by a majority of the membership at a Special Meeting of the Membership duly called on notice and commenced at 10:00 A.M. on the 2nd day of December, 1985, and adjourned at 10:20 A.M. on the same date at 300 N. 6th, Boise, Idaho.

These Articles of Amendment are dated this 2nd day of December, 1985.


