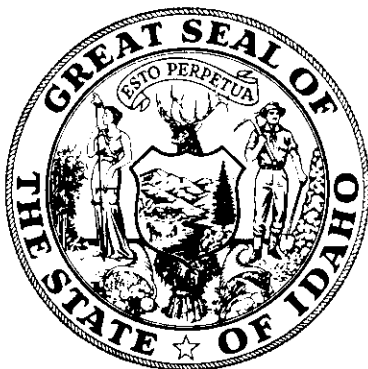

We, the undersigned, have associated ourselves for the purpose of forming a corporation under the provisions of Title 30 of the Idaho Code and to that end, certify as follows:

Article I

The name of the corporation shall be Cafe Rose, Inc.

Article II

This corporation shall have perpetual existence.

Article III

The purpose of this corporation is to conduct any or all lawful business for which corporations may be incorporated under this act.

Article IV

The corporation shall have the authority to issue 10,000 shares of Cafe Rose, Inc. common stock, the par value of each share being ten dollars (\$10.00). This shall be the only class of stock issued by the corporation.

Article V

The initial registered office of the corporation shall be 499 Main Street, Boise, Idaho 83702. The initial registered agent at that address is Jim Owen.

Article VI

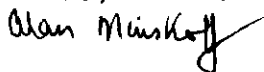
Provisions for the regulation of the internal affairs of the corporation shall be contained in the by-laws of the corporation.

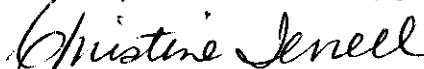
