

ARTICLES OF INCORPORATION
of the
WEISER ELECTRIC LIGHT AND POWER COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS:

That We, the undersigned resident citizens of the United States and of the State of Idaho, do hereby voluntarily associate ourselves together for the purpose of organizing a corporation, under and subject to the Laws of the State of Idaho, and by these presents we do hereby set forth the following to be the Articles of this Incorporation.

FIRST

The name of this Company is the Weiser Electric Light and Power Company, Limited .

SECOND .

The purpose for which it is formed is for the building, equipping, operating and maintaining water and electric power and for transmitting and selling the same for lighting, heating or any mechanical purpose .

THIRD.

The place where its principal business is to be transacted is at Weiser, Washington County, State of Idaho .

FOURTH

The term for which this Corporation is to exist shall be fifty years.

FIFTH.

There shall be five Directors and the names of those selected for the first year , and their residences are as follows:

SIXTH.

The amount of Capital Stock is Fifty Thousand Dollars (\$50,000.00) divided into Five Hundred (500) Shares of the par value of One Hundred Dollars (\$100.00) each.

SEVENTH.

The amount of Capital Stock actually subscribed is Forty Thousand Dollars (\$40,000.00) ; and the following are the names of those by whom the same has been subscribed and the amount subscribed by each:-
