ARTICLES OF INCORPORATION  
OF

APPLE BLOSSOM FESTIVAL, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all being competent citizens of the United States of America, and all having reached the age of majority, have this day voluntarily associated ourselves together for the purpose of forming a non-profit corporation under the laws of the State of Idaho, and do hereby adopt the following as our Articles of Incorporation.

ARTICLE I

The name of this corporation shall is APPLE BLOSSOM FESTIVAL, INC.

ARTICLE II

The purpose and objects for which this non-profit corporation is formed are as follows:

(a) To enhance the City of Payette by providing entertainment and recreation to the citizenry through the APPLE BLOSSOM FESTIVAL.

(b) To exercise generally the powers customarily exercised by non-profit business corporations.

(c) To carry on, or to do anything in connection with the objects and purposes above mentioned that may be essential, necessary, proper, expedient, or merely convenient for the corpo-

ration to accomplish success or promote the said objects and purposes of the corporation. The foregoing clauses, by reason of the specific enumeration of powers, shall not be held to restrict the powers of the corporation to do any of the things within the purview of its general purposes.

(d) To qualify as a tax exempt organization pursuant to Section 50 (c) (3) of the United States Internal Revenue Code.

### ARTICLE III.

This corporation shall have perpetual existence.

### ARTICLE IV.

The principal place of business shall be P. O. Box 104, Payette, Idaho 83661, and the location and mailing address of the registered office in this state shall be 6 North Main Street, P.O. Box 104, Payette, Idaho 83661, and the registered agent shall be LEE NELSON of the same address.

### V.

This corporation shall be a non-profit corporation and shall have no stock and no dividends, no pecuniary profits shall be declared or paid to the members thereof, or to any other private individual. All of its earnings shall be used to further the purposes of this corporation as hereinabove set forth. This corporation shall be operated at all times to qualify for tax exempt treatment under Section 501 (c) (3) of the United States Internal Revenue Code. In the event of dissolution, any assets shall be distributed to the Payette Education Foundation, a 501

(c) (3) non-profit corporation.

VI.

The corporate powers of said corporation shall be vested in the Board of Directors, five (5) in number, which may be increased or decreased by a majority vote of the board. The articles and the By-Laws of this corporation may be amended by a simple majority of the Board, or a simple majority of the members. ARTICLE VII.

The members of the corporation shall have the power to establish By-Laws for the operation of the affairs of this corporation which shall in general be in conformity with and pursuant to the principles and purposes of the APPLE BLOSSOM FESTIVAL, INC.

ARTICLE VIII.

Membership shall be open to anyone who desires to participate in the APPLE BLOSSOM FESTIVAL activities. Persons

serving on the board will be automatically considered members.

#### ARTICLE IX

Should any provision of these Articles be found to violate any state or federal law, the remaining provisions shall constitute the Articles of Incorporation.
