ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is Olson Farm, Inc.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The corporation is organized for the purpose of conducting and transacting any or all lawful business to the conduct of farming operations in Latah County, Idaho, purchase and selling land in Latah County, Idaho, and conducting timber operations in Latah County, Idaho.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 100,000; which shares shall have a par value of \$1.00.

ARTICLE V

Provisions for the regulation of the internal affairs of the corporation are as shall be set forth in the bylaws of the corpora-
