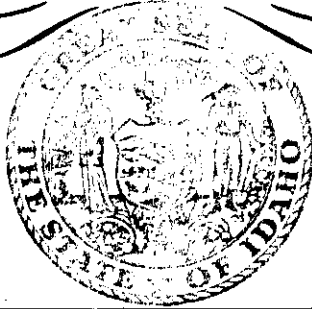

"The West half of the Southwest quarter, Section 13; the East half of the Northeast quarter of the Southeast quarter, the Southeast quarter of the Southeast quarter, Section 14; The East half of the Northeast quarter, Section 23; The Northwest Quarter the West half of the Northwest quarter of the Northeast quarter, the Southwest quarter of the Northeast quarter, Section 24, all in Township 51 North Range West of the Boise Meridian, containing 440 acres more or less, Kootenai County, State of Idaho.

Published dates June 15-22, 1955.

Order creating the village
of Hayden, Idaho and appointing five qualified Persons
as Trustees:

A petition having on the 13th day of June, A. D. 1955, been presented to the Board of County Commissioners of Kootenai County, Idaho, for the creating of the village of Hayden, Idaho, and a public hearing having been held on said petition after due notice given as required by Section 50-701 Idaho Code, as amended, and it appearing from the petition, the record, maps, files and oral evidence presented to the Board of County Commissioners that a majority of the taxable inhabitants of the proposed village have signed the petition and that inhabitants to the number of 125 or more are actual residents of the territory described in said petition, and no objections having been filed against the said petition, and it appearing that the petition, records and files are in proper order and that all things required to be done have been done and the Board being satisfied that a majority of the taxable inhabitants of the proposed village have signed such petition, the Board of County Commissioners does hereby declare that the said proposed village of HAYDEN, Idaho, be and the same hereby is incorporated; the Clerk is directed to enter this Order of Incorporation upon the records of Kootenai County, Idaho; and the Board of County Commissioners named persons having the qualifications provided in Section 50-703 Idaho Code, be and they hereby are appointed as trustees of said village to hold offices and perform the duties required of them by law until the election and qualification of their successors, as provided by law.
