The undersigned, acting as incorporator, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, hereby adopts the following Articles of Incorporation for such corporation.

### **ARTICLE I**

The name of the corporation shall be Melaleuca of Korea, Inc.

# **ARTICLE II**

The corporation is to have perpetual existence.

#### **ARTICLE III**

The aggregate number of shares that the corporation shall have authority to issue is one million (1,000,000) shares with no par value. Of the one million (1,000,000) authorized shares, one hundred thousand (100,000) shares shall be Class A voting common stock, and nine hundred thousand (900,000) shares shall be class A non-voting common stock. The rights of both classes of stock shall be identical except with respect to voting rights. The class A non-voting common stock shall have no right to vote on any issue. Holders of class A voting common stock shall have the right to cumulate their votes for directors.

#### **ARTICLE IV**

The corporation elects to have preemptive rights.

#### **ARTICLE V**

- c. A violation of section 30-1-833, Idaho Code; or
- d. An intentional violation of criminal law.

# **ARTICLE VIII**

- e. An intentional violation of criminal law.
