Pursuant to the provisions of ORS 57.370 (Section 56, Chapter 549, Oregon Laws 1953) of the Oregon
Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment:
1. The name of the corporation is CASCADE PARKING, IMC.
2. The following amendment of the Articles of Incorporation was adopted by the shareholders of the
corporation on July 28 , in the manner prescribed by the Oregon Business
Corporation Act:

RESOLVED, That the Articles of Incorporation of Cascade Parking, Inc., an Oregon Corporation, filed with the Corporation Commissioner of the State of Oregon on July 10, 1958, be and hereby are amended as follows:

Article III thereof is deleted and a new Article III in lieu thereof shall read as follows:

## Article III.

"The aggregate number of shares which the Corporation shall have authority to issue shall be 1,000 shares of common stock being of one class only, each share to be of a par value of \$10.00, constituting an authorized capital of \$10,000."
