ARTICLE OF AMANDMENTS OF AH '88

TO THE ARTICLES OF INCORPORATION

OF HILLSIDE WATER USERS, INC.

Pursuant to the provisions of the Idaho Business Corporation Act, the undersigned officers of the corporation hereby certify that the corporation adopts the following Article of Amendment to its Articles of Incorporation:

FIRST

The name of the corporation is Hillside Water Users, Inc.

SECOND

The following Amendment of the Articles of Incorporation was adopted by the members of the corporation on the 30th day of March, 1988, in the manner provided by Section 30–146 of the Idaho Code; Article XIV is hereby added:

ARTICLE XIV

A director of the corporation shall have no personal liability to the corporation or its shareholders for monetary damages for breach of fiduciary duty as a director; provided that this Article shall not eliminate or limit the liability of a director for:

- a. Any breach of the director's duty of loyalty to the corporation or its shareholders.
- b. Acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law.
- c. Any action for which liability is provided under Section 30-1-48, Idaho Code.
- d. Any transaction from which the director derived an improper personal benefit.
- e. Any act or omission occurring prior to the effective date of the adoption of this Article XIV.

No repeal of or amendment to the foregoing provisions of this Article XIV by the shareholders of the corporation shall adversely affect any right or protection of a director of the corporation existing at the time of such repeal or amendment.

IHIRD

The members of the corporation at the time of such adoption were 18; and the number of members entitled to vote thereon was 18.

EOURTH

The number of members voting for such amendment was 12. The number of members voting against such amendment was 0.
