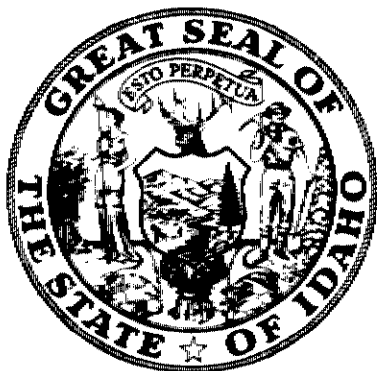

ARTICLES OF INCORPORATION
OF

ARTICLE I.

NAME

This organization shall be known as the FUGOWEE 4-WHEEL DRIVE CLUB, INC.

ARTICLE II.

NON-PROFIT CORPORATION

This corporation is organized as a non-profit corporation in the State of Idaho.

ARTICLE III.

TERM OF EXISTENCE

This corporation shall have perpetual existence.

ARTICLE IV.

PURPOSE

The purposes for which this corporation is formed are and shall be: To promote and organize 4-wheel drive rallies and contests for the purpose of raising money for community purposes in the Kamiah valley. To promote the welfare of the general community through these various events and to sponsor youth participation in these community activities. To enter into agreements, contracts, purchases, sales and other agreements relating to this program and which shall be necessary and expedient for the purposes of this corporation; to do anything not prohibited by law, necessary or requisite for the furthering of the purposes of this corporation.

ARTICLE V.

MEMBERSHIP

This corporation is not organized for pecuniary profit and shall not have or issue any capital stock, but shall issue membership certificates to any organization and/or individual who shall desire to assist with and be a member of said organization. All of the rights and interest of each member shall be equal and no member may have or acquire a greater interest than any other member therein. Such membership cannot be assigned or transferred, so that by such transfer the transferee may become a member of the corporation except by resolution of the Board of Directors under such regulations as may be prescribed by the By-Laws.

ARTICLE VI.

PRINCIPAL PLACE OF BUSINESS

The location and the principal place of business of this corporation and registered office shall be Rt. 2, Box 210, Kamiah, Lewis County, Idaho.

The initial registered agent of the corporation shall be Randy Daugherty, Rt. 2, Box 210, Kamiah, Idaho 83536.

ARTICLE VII.

DIRECTORS

This corporation shall have three (3) Directors, who shall at all times be citizens of the United States. The name and addresses of the original Directors of this corporation are as follows:

AMENDMENTS

These articles of incorporation may be amended by a quorum of the membership who must be present at any meeting called by the chairman after notice, as required by the appropriate provisions of the Idaho Code.

ARTICLE X.

TERMINATION

At the dissolution of this corporation or its termination, by other means, any funds remaining in the treasury of this corporation shall be paid to some charitable organization designated by the membership for that purpose.
