The text of each amendment is as follows:

Article 2: The purpose for which the corporation is organized is to advance quality of crime prevention in Emmett area exclusively for charitable, religious, educational & scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of IRS code or corresponding section of any future federal tax code.

Article 8: Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code or shall be distrubuted to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by the court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
