

ARTICLES OF AMENDMENT OF THE  
ARTICLES OF INCORPORATION OF  
CLEVELAND & CLEVELAND, INC.

Pursuant to the provisions of the Idaho Business Corporation Act, Idaho Code Section 30-1-1, et seq., Cleveland and Cleveland, Inc. hereby adopts the following amendments to its Articles of Incorporation:

1. The name of the Corporation is Cleveland & Cleveland, Inc.;
2. Article I of the Articles of Incorporation is hereby amended to provide as follows:

I.

The name of the corporation shall be  
Affinity Group Resources, Inc."
3. Article VI.A. of the Articles of Incorporation is hereby amended to provide as follows:

To act as a sales agent for  
telecommunications services."
4. The amendments to the Articles of Incorporation set forth in 2 and 3, above, were adopted and approved by Douglas Cleveland and Anna Mae Cleveland, the holders of all of the issued and authorized stock of the corporation, on March 4, 1992.
5. There are one hundred shares of stock outstanding in the corporation; all of said stock is of the same class; both of the holders of such shares were entitled to and did consent to and approve the amendments set forth in 2 and 3, above.
6. The amendments do not provide for an exchange, reclassification or cancellation of issued shares.

7. The amendments do not effect a change in the amount of stated capital.
