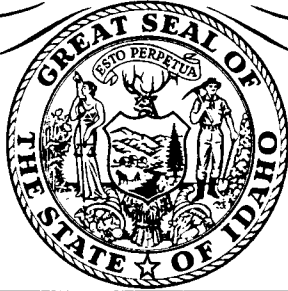

ARTICLES OF AMENDMENT

OF

STARCRAFT MANUFACTURING, INC.

STARCRAFT MANUFACTURING, INC. a corporation organized, acting and existing under and by virtue of the laws of the State of Idaho, by its shareholders, hereby amends its Articles of Incorporation heretofore filed in the office of the Secretary of the State of Idaho, by amending and changing Article I of its said Articles of Incorporation reading as follows, to-wit:

"The name of the corporation shall be: STARCRAFT MANUFACTURING, Inc., to be changed as follows:

The name of the corporation is SUNSHINE MANUFACTURING, Inc."

That the aforementioned amendment to its Articles of Incorporation was duly and regularly adopted at a meeting of the shareholders of the corporation duly called and held for such purpose on the 22nd day of September, 1969, said notice for such meeting being given to the shareholders on the 15th day of August, 1969. The aforementioned amendment was adopted by the affirmative vote of all the shares of the capital stock of said corporation, and no shares were voted against such amendment. That upon adoption of said amendment by the shareholders of said corporation, the number of shares of said corporation outstanding was 5,000 and the number of shares entitled to vote upon the said amendment was 5,000.
