was filed in the office of the Secretary of State on the nineteenth day of May A. D. One Thousand Nine Hundred forty-nine and is duly recorded on Film No. 20 of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and Sections 30-1001 to 30-1005, inclusive, Idaho Code, ~~repealed~~.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for perpetual existence from the date hereof, with its registered office in this State located at

ARTICLES OF INCORPORATION

of

IDAHO STATE TRAP-SHOOTING ASSOCIATION, INCORPORATED

KNOW ALL MEN BY THESE PRESENTS THAT:

We, the undersigned, being all citizens and residents of the State of Idaho, have this date voluntarily associated ourselves together for the purpose of forming a non-profit corporation without capital stock under the laws of the State of Idaho, and we do hereby certify:

ARTICLE I

That the name of said corporation shall be:

IDAHO STATE TRAP-SHOOTING ASSOCIATION, INCORPORATED.

ARTICLE II

That the location of the principal and registered office for the transaction of the business of the corporation shall be the city of Boise, in the State of Idaho, or such other place or places within said State of Idaho, as the corporation may from time to time determine.

ARTICLE III

The corporation shall have perpetual existence from and after the date of its incorporation.

ARTICLE IV

That this corporation shall be a non-profit corporation and that its objects and purposes are to do in the State of Idaho any and every of the things herein set forth in the same extent as natural persons might and could do in furtherance, and not in limitation of, their powers conferred by the State of Idaho, and do hereby expressly provide that the corporation shall have the power:

(a) To encourage, foster, develop, and promote the sport of trap-shooting within the State of Idaho.

(b) To take, hold, lease, mortgage, or purchase, acquire by operation of law, or otherwise any real property or any interest therein or appurtenant thereto, which may be necessary or proper or convenient for the conduct of the business of and the carrying out of the purposes of the corporation.

(c) To take, receive, use, hold, and apply funds and gifts to carry out the purposes for which this corporation is formed.

(d) To co-operate with the amateur trap-shooting association in its development of any programs to incorporate and promote the sports of trap-shooting.

(e) To do anything necessary and proper in the attainment of the objects and purposes for which this corporation is formed, and the foregoing powers are not to be construed as restricting or limiting the power of this corporation to carry out the objects and purposes for which this corporation is formed, either as principal, agent, or otherwise to the same extent as natural persons might or could do.

(f) To conduct the business and affairs of the corporation as the Board of Directors duly elected may from time to time determine.

ARTICLE V

This corporation does not and shall not have any capital stock nor shall it issue to its members any certificates representing capital stock in this corporation. This corporation is not operated for pecuniary profit but shall be and is a non-profit corporation.

ARTICLE VI

Membership in this corporation shall not entitle any person to any interest whatsoever to the assets of the corporation, but shall permit said person holding membership in said corporation to participate only in the management of the affairs of the corporation transacted in meetings of its members regularly called and held within the period covered by such membership.

ARTICLE VII

Members of this corporation shall not be subject to assessment for the purposes of paying the expenses of the corporation or for the conducting of business, or for the payment of debts and obligations of the corporation.

ARTICLE VIII

The affairs and business of this corporation shall be conducted by a Board of Directors consisting of seven

in number, and their qualification and manner of election shall be as provided in the By Laws of said corporation.

ARTICLE IX

These Articles of Incorporation may be amended at any regular or special meeting of this corporation called for that specific purpose, provided, however, that any amendment must first be approved by a vote of a majority of the Board of Directors, and a quorum thereof shall consist of at least four members.
