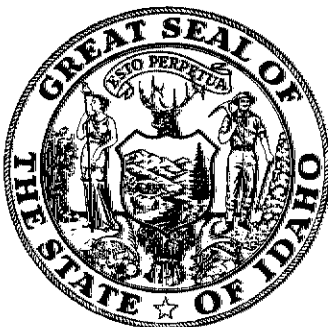

ARTICLES OF INCORPORATION

STATE OF IDAHO

FIRST: The name of this corporation is I.O.C. LEGAL RESEARCH, INC.

SECOND: The duration of said corporation shall be perpetual.

THIRD: Its registered office in the State of Idaho is to be located at 10400 Overland Rd., Suite 353, Boise, Idaho, County of Ada. The registered agent in charge thereof is Carolyn E. Rohme, address "same as above".

FOURTH: The nature of the business and the objects and purposes proposed to be transacted, promoted and carried on, are to engage in legal research and any lawful act or activity for which corporations may be organized under the Idaho Business Corporation Act of the State of Idaho.

FIFTH: The amount of total authorized shares of stock of this corporation is 1000 shares of NO par value.

SIXTH: The name and mailing address of the incorporator is:

SEVENTH: All of the corporation's issued stock, exclusive of treasury shares, shall be held of record by not more than thirty five (35) persons.

EIGHTH: All of the issued stock of all classes shall be subject to one or more of the restrictions on transfer permitted by section 30-1-23A of the Idaho Business Corporation Act.

NINTH: The corporation shall make no offering of any of its stock of any class which would constitute a "public offering" within the meaning of the United States Securities Act of 1933 as it may be amended from time to time.

TENTH: Directors of the corporation shall not be liable to either the corporation or its stockholders for monetary damages for a breach of fiduciary duties unless the breach involves: (1) a director's duty of loyalty to the corporation or its stockholders; (2) acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law; (3) liability for unlawful payments of dividends or unlawful stock purchases or redemption by the corporation, provided for under section 30-1-48, Idaho Code; (4) a transaction from which the director derived an improper personal benefit; or (5) a breach of Proprietary Information Agreement which shall be signed and agreed to by all corporate directors.
