The name of this corporation shall be The Taylor Canal Company.

## Purposes.

Its purpose is to construct, own and control a canal and the necessary lateral ditches at Taylor, Bingham County, Idaho, from the South East corner of Section Twenty-eight (28) Township Two (2) North of Range Thirty-eight (38) East of the Boise Meridian to the foot hills in a South East direction and thence South West to the East line of Section Thirty-one (31) of Township One (1) of the same Range for irrigation and domestic use.

## Place of Business

Its office and principal place of business shall be Taylor, Idaho Falls Post Office, State of Idaho.

## Time of existence

The life of this corporation shall be fifty years from the date of the issue of Certificate of its incorporation.
