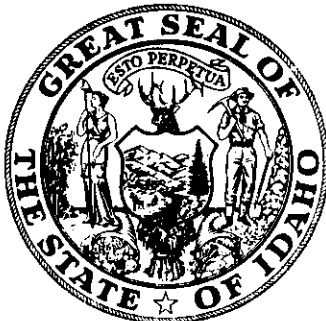

All property and assets remaining in the corporation at the time of dissolution have been distributed or are being distributed among the shareholders in proportion to their respective rights and interest.


## VII. PENDING LITIGATION

There are no suits pending against the corporation in any court.


### VIII. BASIS FOR DISSOLUTION



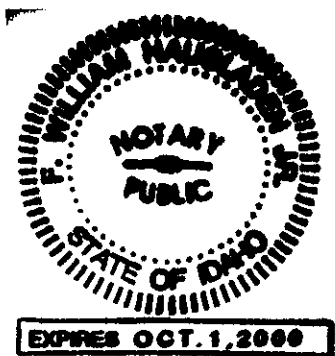


