ARTICLES OF INCORPORATION BRENNAN ENTERPRISES, INCORPORATED

WE, THE UNDERSIGNED, natural persons over the age of 21 years, acting as incorporators of a corporation under the laws and Code of the State of Idaho, adopt the following Articles of Incorporation for such corporation.

ARTICLE I.

NAME

The name of the corporation is BRENNAN ENTERPRISES, INCORPOR-

ARTICLE II.

DURATION

The period of duration shall be peretual.

ARTICLE III.

PURPOSES

To engage generally in the motel and related businesses; to plan, design and construct buildings for motel purposes and to buy, sell and acquire the same to carry on the motel business and such accommodations necessary to accomplish such purposes;

To own, hold, rent, control, lease, operate, conduct and engage in the restaurant business; and to furnish, equip and manage

restaurants, inns, eating houses, taverns, cafes, cabarets or places of entertainment, and generally to do and perform everything necessary for carrying out the aforesaid purposes; and to prepare, market, import and export food and food products of every class and description, fresh, canned, preserved or otherwise, and to prepare and serve all food, beverages, alcoholic or nonalcoholic and other preparations and refreshments of all kinds;

To engage in the on-sale dispensing of alcoholic beverages operating as a bar, lounge and restaurant, and generally to purchase or otherwise acquire bars, lounges, restaurants and taverns and to manage, own, hold, lease, rent or sell such business or businesses;

To promote fellowship and extend acquaintanceship by means of dances, musicals and other kindred forms of entertainment;

To engage generally in any causes or objects similar to the above mentioned in order to promote the cultural, social, literary and general welfare of the community and thereby promote tourism and the local economy wherein the corporate establishments may be doing business; and

In addition the corporation shall be authorized to own, buy, sell, trade and otherwise deal in property of all kinds and descriptions, including real, personal intangibles or mixed, and to engage in any and all other lawful purposes, activities or pursuits whether similar or dissimilar to the foregoing and to have all powers allowed by law, including those described in the Corporate Laws of Idaho.

ARTICLE IV.

CORPORATE STOCK

The aggregate number of shares which the corporation shall have authority to issue is 100,000. The shares shall be without par value. These Articles of Incorporation may be amended to increase the capitol stock by a majority vote of the shareholders at any regular or special stockholders' meeting called for that purpose.

No shareholder shall transfer, alienate, or in any way dispose of any share of the corporation. The corporation reserves and has the exclusive right and option to purchase such shares at a price equal to the book value thereof.

ARTICLE V.

PAID IN CAPITAL

The corporation shall not commence business until at least \$1,000.00 has been received by it as consideration for the issuance of shares.

ARTICLE VI.

BOARD OF DIRECTORS

The number of directors constituting the initial board of directors of the corporation is three (3), and the names and the addresses of the persons who are to serve as such directors until the first annual meeting of the shareholders, or until their successors are elected and qualified are:
