RE: Puget Sound Bank Equity Fund, LP - Use of the Word "Bank" in Company Name in Idaho

Dear Mr. Vegwert:

The Idaho Department of Finance (Department) has reviewed your emailed letter dated September 30, 2015 requesting approval by the Department as to the use in Idaho of the entity name "Puget Sound Bank Equity Fund, LP" (PSBEF). As you indicated in your letter, PSBEF is a limited liability partnership that was formed between yourself and four others in 1995 for the purpose of investing in Puget Sound Bank, which is located in Bellevue, Washington. We understand that because you failed to seek approval from the Department for use of the word "bank" in your entity's name when you originally attempted to register PSBEF with the Idaho Secretary of State, PSBEF never became registered. It is also our understanding that you and your partners now wish to sell your stock and dissolve PSBEF, but in order to do so, you must first register PSBEF with the Idaho Secretary of State. Finally, we understand that PSBEF conducts no trade or business in the state of Idaho.

Idaho Code § 26-1202 generally prohibits persons from advertising or transacting business in this state under a name or title containing the word "bank," "banker," or a word or words of similar import, unless the person holds a banking charter. The Director of the Department may grant a waiver to allow the use of the word "bank," "banker," or words of similar import in certain circumstances. The waiver may be granted if:

- (a) The person is not engaged in banking or trust business;
- (b) The name or title used is not likely to deceive or mislead an individual to believe that the person is engaged in banking or trust business;
- (c) The name or title, or a name or title similar to it, is not already used by another person doing business in this state; and
- (d) The name or title does not suggest or imply that the person is engaged in unlawful conduct.
