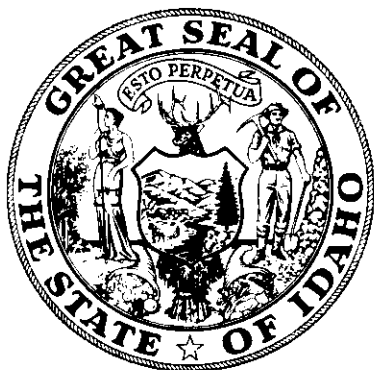

ARTICLE ONE


THE NAME OF THE CORPORATION SHALL BE IMAGE DE IDAHO, INC.






